

PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:
  - (a) Complainant, Carol Troutman, and Respondent, PPL, agree that Complainant will pay \$315 by March 6, 2012. Thereafter, Complainant will pay her monthly budget bill plus \$84 per month towards arrearages, until all arrearages are paid in full.
  - (b) Complainant agrees to withdraw her Complaint.
