

CERTIFICATE OF SATISFACTION OF COMPLAINT


1. Complainant is Caroline Combs.

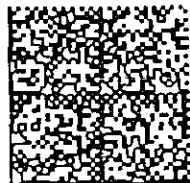
