

UPS CampussShip: View/Print Label

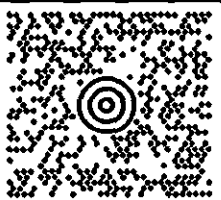

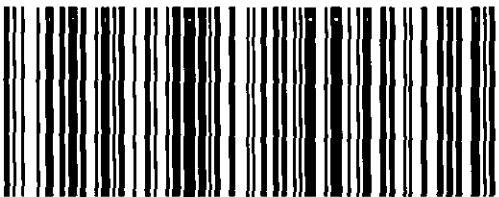
