**Discovery Questions and Evidence requested of PPL for Roy and Cindy Maurer

We again seek clarification on an answer to a discovery question partially answered by PPL on January 3, 2012 and again on January 30, 2012.

- 1. Question for discovery for both PPL responses :
The 36-02 line leaves the study area: We are seeking discovery from PPL for, a complete grid system map of the "entire" 36-02 12kV line.**

The complete and "entire" grid system of the 36-02 12 kV line is **not** depicted in either map supplied by PPL on the January 3 or January 30 discovery response.

It's becoming apparent that PPL may be intentionally stalling on the answer or otherwise incompetent in both responses. We certainly hope our judgment is wrong in both cases. The 36-02 line continues south on the East side of the Susquehanna River beyond both map borders. The full and entire 36-02 12 kV line is not depicted on either map supplied by PPL.

Again, for a third time, we respectfully request, a "complete" and "entire" grid system map of the 36-02 12 kV line for discovery without further delay.

We are likely to have many other questions of PPL as the proceeding progresses so these are not meant to be questions in entirety.


