CERTIFICATION OF SATISFACTION

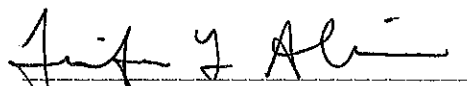

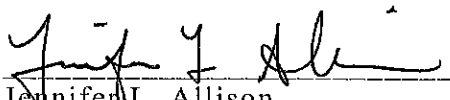

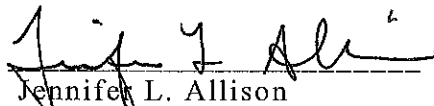
