The purpose of this letter is to report on the status of the above-referenced matter. Pursuant to the Interim Order issued February 17, 2012, Complainant Anil Aras and Respondent PPL Electric Utilities Corporation ("PPL Electric") held a telephonic conference to discuss and address the concerns and issues raised in Mr. Aras' Formal Complaint. The conference was held at 12:00 p.m. on February 29, 2012. Participating at the conference on behalf of PPL Electric were Doug Krall, Manager – Regulatory Strategy at PPL Electric, Jennifer Tomel, Customer Service Representative at PPL Electric, and Christopher T. Wright, counsel for PPL Electric.

At the settlement conference, the Parties were unable to fully and amicably resolve the issues raised by the Complaint. Given the results of the settlement conference, PPL Electric believes mediation before the Pennsylvania Public Utility Commission could facilitate the resolution of this matter. PPL Electric therefore requests this matter be scheduled for mediation.


