I am responding on behalf of AT&T Communications of Pennsylvania, LLC, TCG Pittsburgh and TCG New Jersey, Inc. (together, "AT&T") to your letter of March 6, 2012 concerning Verizon's February 17, 2012 letters identifying issues with certain VoIP tariffs submitted by the respective carriers in the above-referenced dockets. AT&T is in general agreement with the issues and with the need for corrective action to those tariffs identified by Verizon. AT&T also is willing to participate in the informal consultative process established in your March 6 letter to address those issues. We do not understand such participation to waive AT&T's rights to pursue formal action before the Commission with regard to the subject tariffs

or any future filings pursuant to the Federal Communications Commission's November 18, 2011 *Connect America Fund* order.
