CERTIFICATE OF SATISFACTION OF COMPLAINT


1. Complainant is Karen Swisher.



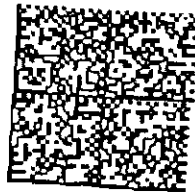

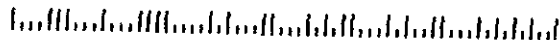
