(b) At the time of the Hearing, PPL intends to call Customer Service Representative, Marilyn Gonzalez, as its witnesses. Ms. Gonzalez is an employe of PPL Electric Utilities Corporation, with knowledge of the Complainant's Complaint, account, and outstanding balance. In addition, Ms. Gonzalez will testify to PPL's policy with regard to payment arrangements on residential accounts.
