(a) Complainant, Helene Nagy, and Respondent, PPL, agree that PPL will apply a credit to Complainant's account in the amount of \$422.11, which represents the late fees charged to Complainant's account. It is further agreed that beginning with the bill due April 2012, Complainant will pay her monthly budget bill (currently \$147) plus \$101 per month towards arrearages, until all arrearages are paid in full.


(b) Complainant agrees to withdraw her Complaint.


