Dear Mr. Bingaman:

The percentage of increase in hourly rates was determined by using the straight time period under Column 4 using the driver charge, the additional man charge and the 26 foot straight truck. The last increase in hourly rates took effect August 2, 2010. Based on a vehicle, driver and two helpershthe the van and three man charge was \$118.00 per hour. The proposed van and three man charge is \$122.00 per hour applying a \$33.00 driver charge, \$31.00 for each additional helper and 26 foot stright truck of \$27.00 per hour. Applying the \$4.00 increase divided into \$118.00 equals 3.4% increase. We have to keep the comparison consistant in order to maintain consistency in determining the applicable percentage of increase in hourly rates.

<u>ITEM 350</u> (A)

Applicable to Class 1 shipments transported distances of forty (40) miles or less. Subject to Notes 1 to 8 below, the transportation charge on any shipment shall be a COMBINATION of the applicable TRAVELING CHARGE named in Column 1 plus HOURLY CHARGE at applicable rates named in Columns 2, 3 or 4.

Hourly rates apply only from time of arrival of vehicles and men at first point of origin (continue during all loading, transportation from first point of origin to final destination, and unloading) until completion of unloading and dismissal of vehicles and men by shipper at destination.

Traveling charges cover traveling to first point of origin and traveling from final destination, irrespective of actual time involved in such traveling.

- Note 5 When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.
- Note 6 Except as otherwise applicable minimum total transportation charges on:
 Holidays and Sundays 8 hours at rates named in Columns 1 and 2.

 Saturdays and Weekdays 4 hours at rates named in Columns 1 and 3 or 1

- Note 7 Carrier will supply and charge for supervisor or supervisors as requested by shipper. Hourly rate for each supervisor will be computed from time of arrival of vehicles and men at first point of origin until completion of unloading and dismissal of vehicles and men at final destination, unless other time of arrival or dismissal of supervisor is provided by agreement between shipper and carrier.

Our company is seeking an hourly rate increase on shipments transported distances of forty (40) miles and less.

In accordance with 52 Pa. Code 23.67 Financial Data, I have attached a document that reflects the provisions of this section.

Our 2011 Pennsylvania Gross Revenues amounted to \$5,399,525. Applying the one (1) percent times that amount is \$53,995.25. Our 2011 household goods in use under 40 mile revenues amounted to \$1,250,340. Applying the 3.4% increase times that amount is \$42,512.00 which meets the criteria of this Section.
