

CERTIFICATE OF SATISFACTION OF COMPLAINT

1. Complainant is Darlene Gall.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:
 - (a) Complainant, Darlene Gall, and Respondent, PPL, agree that (1) PPL will apply a ten (\$10) dollar credit to Complainant's account, which shall offset a ten (\$10) dollar charge applied to the account for a check returned for NSF, and (2) PPL shall issue a re-bill to Complainant which credits Complainant for 470 kWh.
 - (b) PPL represents that it is now PPL's current practice to issue correspondence to customers applying for net metering which encourages customers who

shop for generation to confirm with their EGS whether the EGS reimburses customers for excess generation.

(c) Complainant agrees to withdraw her Complaint. The Office of Consumer Advocate has intervened in the within case, and is in agreement with the filing of the Certificate of Satisfaction.





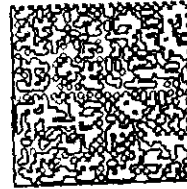
