CERTIFICATION OF SATISFACTION

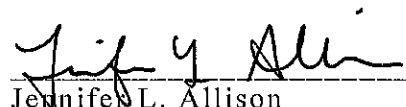

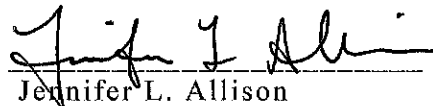

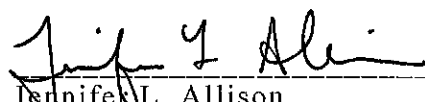
