Dear Ms. Chiavetta:

I received the decision in the above case in my post office box in Scotrun only today April 10, 2012. As the postmark was clearly March 15, 2012, the envelope had a certified mail sticker, and the letter claimed certified mail receipt requested I was curious what had happened and went to the post office to investigate.

The Post Office claimed that the letter was picked up by a "Ruth Linamer" and gave me the print-out of her pick-up on March 20 at 3pm. This person is unknown to me. I have attached a copy of the delivery receipt. The house is currently rented to Ms. Hideka Gouda, who also did not know the person who signed for the document.


As the 20 days from the issuance of the Initial Decision has now expired (March 14 + 20 days = April 3), it is impossible for me to even consider Exceptions to the Initial Decision within the prescribed time period.

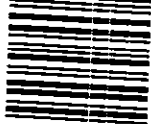
