Re: BlueStar Energy Services, Inc. d/b/a BlueStar Energy Solutions Notice of Change in Ownership Structure

Dear Ms. Chiavetta:

In accordance with Section 54.34 of the Pennsylvania Code, BlueStar Energy Services, Inc. d/b/a BlueStar Energy Solutions ("BlueStar") hereby notifies the Pennsylvania Public Utility Commission ("Commission") of a change in its ownership structure and other information related to its electric generation supplier ("EGS") license issued in Docket No. A-2009-2132755.

BlueStar is wholly-owned by BSE Holdco, LLC, which is wholly-owned by BlueStar Energy Holdings, Inc. On March 7, 2012, AEP Retail Energy Partners LLC ("AEP Retail Energy") acquired 100% of the issued and outstanding stock of BlueStar Energy Holdings, Inc. In turn, AEP Retail Energy is now an upstream indirect owner of BlueStar. AEP Retail Energy is wholly-owned by AEP C&I Company, LLC, which is wholly-owned by American Electric Power Company, Inc. (collectively, "AEP entities"). An organization chart depicting BlueStar's new corporate structure is attached hereto as Attachment A.

Although BlueStar is now part of the AEP system, BlueStar anticipates continued operation under its current name, honoring of its current contracts, and provision of service under the same terms and conditions as currently offered to customers. BlueStar continues to demonstrate the financial and technical fitness required by the Commission to be licensed as an EGS. However, the personnel that BlueStar relies upon to meet the technical qualifications have changed and BlueStar provides in Attachments B and C its revised list of officers and personnel that meet these qualifications. In addition, in light of its new ownership structure, BlueStar provides in Attachment D the names of its affiliated companies currently doing business in state and out of state and affiliate(s) currently applying to do business in Pennsylvania, as well as whether the affiliate(s) are jurisdictional public utilities. Finally, BlueStar provides in Attachment E an updated Supplier Contact List. Aside from the changes provided in this

correspondence, the information previously provided to the Commission by BlueStar has not changed.


