- ① Feb. 8, 2011 - Bill \$261.91
- ② March 9, 2011 - Bill \$501.41
- ③ April 7, 2011 - Bill \$432.36
- ④ May 6, 2011 - Bill \$360.22
- ⑤ June 6, 2011 - Bill \$78.61

I told the Law Judge my Life was in danger, yet PECO stated that the PLLC said to, cut my wires over the phone, to me.
