

**MOTION OF PPL ELECTRIC UTILITIES CORPORATION
FOR EXTENSION OF PROCEDURAL SCHEDULE**

PPL Electric Utilities Corporation (“PPL Electric”), by its counsel, files this Motion pursuant to 52 Pa. Code § 1.15 requesting an extension of the procedural schedule established in Prehearing Order #2 issued on December 14, 2011. The basis for this request is to allow sufficient time for the protestants and other owners of land subject to the condemnation

proceedings to investigate the amendments to two of the Applications for Condemnation. The amendments were filed by PPL Electric on April 23, 2012.

The requested extension of time would permit the protestants, their counsel and other owners of land subject to the condemnation proceedings to have the necessary time to review the amendments, conduct additional informal and formal discovery, and prepare supplemental direct testimony regarding the amendments. PPL Electric, through its counsel, has spoken to counsel for the represented protestants in this proceeding regarding this request for an extension, and the protestants through their counsel have expressed that they do not object to PPL Electric's request for an extension.

Therefore, PPL Electric offers the following proposed procedural schedule:




