

CERTIFICATION OF SATISFACTION OF COMPLAINT

1. Complainant is John Sloane (hereinafter referred to as "Complainant").
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. PPL hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission, have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL:

(a) As of June 7, 2011, the Complainant had an overdue balance with PPL of \$4681.87. PPL agrees to reduce the amount of this obligation by fifteen (15%) percent.

(b) Between July of 2011 and the present, Complainant has incurred additional \$1,353.41 on his electric bill. The parties agree that this amount will not be reduced.

(c) Complainant agrees to pay to PPL the sum of \$3,978.87 for the debts he incurred up to and including June of 2011.

(d) In total, Complainant agrees to pay the sum of \$5,333.28 to PPL.

(e) PPL agrees to accept payments on this debt over a period of twenty-four (24) months, beginning with the Complainant's next electric bill.

(f) Broken up over twenty-four (24) months, the Complainant's monthly obligation towards his arrearages is the sum of \$222.22 per month.

(e) Starting with his next electric bill, the Complainant agrees to pay, each month, and for the next twenty-four (24) months, his monthly electric bill (in whatever amount that may be) plus the sum of \$222.22.


(f) Following payment of the twenty-four (24) payments of \$222.22, and assuming that Complainant continues to pay, in addition thereto, his monthly electric bills, then, at the end of the twenty-four (24) month period, the Complainant will have satisfied his overdue balance with PPL.

5. PPL hereby notifies Complainants of the filing of this Certificate of Satisfaction, and that if Complainants objects or disagree with the terms of the Certificate of Satisfaction, Complainants must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests that the docket be marked closed in this matter.

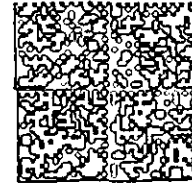
