TO THE HONORABLE, THE PENNSYLVANIA PUBLIC UTILITY COMMISSION:

Pursuant to the provisions of 52 Pa. Code § 5.94(a), the Philadelphia Area Industrial Energy Users Group ("PAIEUG") hereby files this Petition for Leave to Withdraw Petition to Intervene with the Pennsylvania Public Utility Commission ("PUC" or "Commission") in the above-captioned proceeding.

In support thereof, PAIEUG states as follows:

1. On March 30, 2012, PECO Energy Company ("PECO" or "Company") filed an updated Nuclear Decommissioning Cost Adjustment ("NDCA") with the Commission in the above-captioned matter.
2. On April 19, 2012, PAIEUG filed a Petition to Intervene in the proceeding.
3. Since filing the Petition to Intervene, PAIEUG has participated in informal discussions with PECO, through which the Company addressed the issues raised in PAIEUG's Petition to Intervene.
4. Therefore, consistent with 52 Pa. Code § 5.94(a), PAIEUG desires to withdraw its Petition to Intervene.

WHEREFORE, the Philadelphia Area Industrial Energy Users Group respectfully requests that the Commission grant this Petition for Leave to Withdraw Petition to Intervene and remove PAIEUG from party status for this proceeding.
