

Dear Mr. Russell:

On May 14, 2012, Yasmin A. Bhatti filed Exceptions to the (Recommended or Initial) Decision of Administrative Law Judge Katrina L. Dunderdale in the above captioned matter. 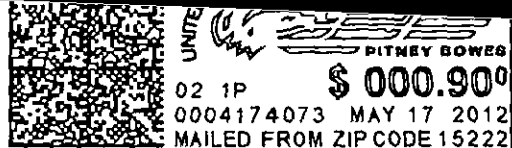
