

**PREHEARING CONFERENCE MEMORANDUM

NOW COMES Dominion Retail, Inc. d/b/a Dominion Energy Solutions, (“DES”) and Interstate Gas Supply, Inc. d/b/a Interstate Energy (“IGS”) and hereby offer their Prehearing Conference Memorandum in satisfaction of the presiding Administrative Law Judge’s Prehearing Conference Order issued May 15, 2012. DES and IGS, by and through their counsel in the above-captioned matter, Hawke McKeon & Sniscak LLP, and hereby jointly submit their Prehearing Conference Memorandum. The parties state as follows:

**I. PROCEDURAL HISTORY**

1. On or about April 27, 2012 Duquesne Light Company (“Duquesne”) filed the above captioned petition with the Pennsylvania Public Utility Commission (“Commission”).
2. On May 9, 2012 DES and IGS filed a Joint Petition to Intervene in the above captioned proceeding.
3. Several other parties have intervened in this proceeding.

4. On May 15, 2012, a Prehearing Order was issued requiring the filing of Prehearing Memoranda on or before June 4, 2012 and setting the date for the prehearing conference as June 8, 2012.

## **II. ISSUES**

5. DES and IGS continue to review the filing. So far DES and IGS have identified the issue of Duquesne's proposed competitive enhancements as one area to which they will devote significant attention, but they reserve the right to address additional issues as they arise in the course of litigation and in response to other issues raised by other parties to this proceeding.

## **III. WITNESS**

6. At this time DES and IGS intend to present the following witness to testify in this matter, however they reserve the right to call additional witnesses as may be warranted upon proper notice to Your Honor and the parties:

8. DES and IGS have not yet engaged in discovery, but, if necessary, will do so at the earliest possible date, so as not to impede the procedural schedule in this case.

## **VI. EVIDENCE**

9. DES and IGS intend to present the testimony of the witness above as well as any exhibits and other evidence that may be pertinent thereto.

## **VII. SETTLEMENT**

DES and IGS are willing and ready to engage in settlement discussions in an attempt to resolve or narrow the issues in this proceeding, with any and all parties, and encourage the parties to engage in settlement early in the process.


