On February 1, 2012, PECO Energy Company filed with the Pennsylvania Public Utility Commission Supplement No. 34 to Electric PA P.U.C. No. 4. PECO Energy agreed to voluntarily postpone the effective date of this tariff until April 30, 2012 with Supplement No. 38. With Supplement No. 42 to Electric PA P.U.C. 

