
Motion for Continuance of Hearing Date

Pursuant to 52 Pa.Code. §1.15(b), Duquesne Light Company ("Duquesne" or "Company") respectfully moves for a brief continuance of the hearing scheduled for June 1, 2012. Pennsylvania Public Utility Commission regulations require that a motion for continuance be made in writing, five days in advance of the hearing, and state good cause. In support of its request, Duquesne states the following:

1. On March 30, 2012, Duquesne filed its Annual Transmission Service Charge Filing for the reconciliation period of March 1, 2011 through February 28, 2012.
2. By notice dated April 27, 2012, an initial hearing was scheduled for June 1, 2012 at 10:00 a.m.
3. The reconciliation statement for the Transmission Service Charge was prepared by or at the direction of William V. Pfrommer, Manager of Rate & Tariff Services. Mr. Pfrommer was aided by Ribeka Garrity, rates analyst for the Company.
4. Both Mr. Pfrommer and Ms. Garrity will not be in the United States on June 1, 2012, and are unavailable for hearing. Mr. Pfrommer and Ms. Garrity are the only Duquesne employees with knowledge of the reconciliation data for the Transmission Service Charge.
5. The undersigned attempted to reach Ms. Allison Kaster, counsel for the Commission's Bureau of Investigation and Enforcement to ascertain her position on the continuance without success.

Wherefore, Duquesne Light Company timely petitions your Honor to continue the above captioned matter for a later date.


