COMPLAINANT DENY(S) THE ALLEGATION BROUGHT BY THE RESPONDENT IN REGARDS TO THE ELIMINATION OF PECO ENERGY'S RH RATE AS WAS APPROVED BY THE COMMISSION ON JUNE 9, 2009, DOCKET NUMBER P-2008-2062739.

COMPLAINANT DISREGARDED THE REPRESENTATIVE'S REMARKS ABOUT THE RH RATES AND WENT ON TO DISPUTE THE ACTUAL ISSUES ABOUT THE BILLS' GENERATION CHARGES AND THE QUESTION ABOUT THE CAP RATE.


