

SCHEDULE OF RATES

Advance Reservations:

Advanced reservations must be made prior to the service being rendered.

Hourly Rates:

Rate: \$1.5 per mile. Rates begin from the time vehicle leaves the parking lot on 347 Philmont Avenue, Feasterville, PA and ends at the time vehicle returns to the parking lot on 347 Philmont Avenue, Feasterville, PA.

Driver Gratuity:

A twenty percent (20%) will be assessed on all fares included herein.

Additional Expenses:

All tolls, parking fees and other out-of-pocket expenses will be the responsibility of the passenger and added to the charge.

Waiting Charge:

Waiting Charge of \$65 per hour will be added to the charge.

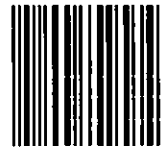
Deposits and Cancellation Policy:
