

 - (a) Complainant, Lawrence Sturchio, and Respondent, PPL Electric, have agreed to a negotiated settlement of \$209.46, leaving Complainant with a balance of \$100. The \$100 will be billed in four (4) installments of current bill plus \$25 per month towards arrearages, until all arrearages are paid in full.
 - (b) Complainant agrees to withdraw his Complaint.




