

CERTIFICATE OF SATISFACTION


1. Complainant is Daniel Augustus.

PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:
 - (a) Complainant, Daniel Augustus, and Respondent, PPL Electric, agree that Complainant filed for bankruptcy on or about August 18, 2012, which was formally discharged. Accordingly, all but \$145.06 of Complainant's disputed balance has been discharged. Complainant agrees to pay such balance (\$145.06) within thirty days.
