MOTION FOR CONTINUANCE OF HEARING

Pursuant to 52 Pa. Code § 1.15(b), Philadelphia Gas Works, the Respondent (PGW) hereby requests a continuance of the telephonic hearing in this matter scheduled for Tuesday, June 19, 2012, as the PGW witness is unavailable due to a death in the family and the his own medical issues. In support of its motion, PGW states as follows:

1. On March 27, 2012, the Commission served the Respondent, PGW with the Complaint filed in the above captioned matter, which is a dispute of a bill for previous unbilled usage 3040 Fairfield Street, Philadelphia, PA, to which PGW filed an Answer to the Complaint in the above captioned on April 16, 2012.
2. By Notice dated April 25, 2012, the Commission scheduled an In Person Hearing in this matter for June 19, 2012 at 2:00 p.m., before Administrative Law Judge (ALJ) Cynthia W. Fordham, in the Commission's Philadelphia office.
3. At the Complainant's request, the hearing was changed to a telephonic hearing to accommodate the Complainant's stress of traveling to a hearing.
4. By notice dated May 25, 2012, the Commission rescheduled the hearing as an Initial Telephonic Hearing to be held on June 19, 2012 at 2:00 p.m. before ALJ Fordham.
5. PGW witness assigned to this matter, Jack Irizarry, is unavailable due to the death of his mother earlier this week and his requiring emergency surgery the result of a chronic medical condition.
6. As the PGW Customer Review Unit is currently understaffed, PGW is unable to provide a replacement witness that can familiarize herself/himself with the PGW investigation of this matter.

7. PGW has contacted the Complainant's in this regard who had indicated that neither he or his wife object to the continuance of the telephonic hearing to another date.

8. PGW has not previously requested a continuance in this matter.

9. Pursuant to 52 Pa. Code § 1.15(b), PGW has shown good cause for the grant of a continuance in this matter.

WHEREFORE, Complainant requests that the telephonic hearing scheduled for June 19, 2012, in the above captioned matter be continued and rescheduled.


