CERTIFICATION OF SATISFACTION

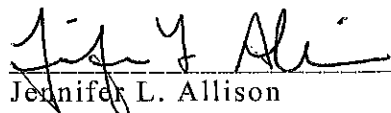

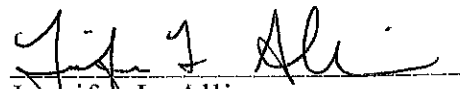
