PUBLIC STATEMENT OF THE
OFFICE OF CONSUMER ADVOCATE
PURSUANT TO 71 P.S. SECTION 309-4(e)

Act 161 of the Pennsylvania General Assembly, 71 P.S. § 309-2, as enacted July 9, 1976, authorizes the Consumer Advocate to represent the interests of consumers before the Pennsylvania Public Utility Commission (PUC or Commission). In accordance with Act 161, and for the following reasons, the Consumer Advocate determined to file an Intervention and participate in proceedings before the Commission involving the Formal Complaint of Donald Stevens v. UGI Penn Natural Gas (PNG) concerning its Gas Beyond the Mains (GBM) program.

On March 14, 2012, Mr. Stevens of 225 Tate Street, Taylor, PA, filed a Formal Complaint with the Commission requesting that PNG connect his residence to the natural gas lines or continue to provide him propane at natural gas rates, instead of increasing the cost of propane to him. As was true with other GBM customers in the proceeding captioned Kathleen Moran-Roberto, et al., v. UGI PNG, Docket No. C-2011-2251178, Mr. Stevens believed that he would receive propane gas at natural gas rates until mains were installed to serve him at his residence.

Through its participation in this proceeding, the OCA seeks to ensure that the interests of the Complainant are duly considered and that Mr. Stevens has an opportunity to be heard as to the issues alleged in his Formal Complaint. The OCA will work to ensure that this Complaint is adjudicated in accordance with the relevant provisions of the Public Utility Code.
