RIGHT-OF-WAY AGREEMENT
Corporation

KNOW ALL MEN BY THESE PRESENTS, That the **North Whitehall Township**, a corporation of Pennsylvania hereinafter called "GRANTOR", intending to be legally bound, does hereby for itself and its successors and assigns grant unto PPL ELECTRIC UTILITIES CORPORATION, hereinafter referred to as "PPL", its successors, assigns and lessees, the right, privilege and authority to construct, reconstruct, operate and maintain its electric and communication lines consisting of overhead wires as shown on plan hereto attached and made a part hereof including, wires, cables, fixtures and apparatus upon, across, over, under and along the property which said Grantor owns or in which it has any interest located along Portland Street, situate in the Township of North Whitehall, County of Lehigh, Commonwealth of Pennsylvania; and along the public highways adjoining the said property, including the right of ingress and egress to and from the said lines for any of the aforesaid purposes; also the right to cut down any and all trees within fifteen (15) feet each side of centerline of the electric/communication line and the right to trim any and all trees within fifteen (15) feet each side of centerline of the electric/communication line and to remove brush along said lines which in the judgment of said PPL menace the said lines; and also the right to permit the attachment of wires and cables of any other person or company to said poles. The said PPL, its successors and assigns shall not be limited in its or their enjoyment of the rights hereby granted as may be first constructed, but shall have at all times in the future the right to construct, operate and maintain and from time to time to reconstruct electric/communication wires, cables, fixtures and apparatus upon, across, over, under and along subject property.

A copy of this agreement and an acceptance hereof by PPL shall be filed by PPL with the Pennsylvania Public Utility Commission, and this agreement shall thereafter become effective in accordance with the provisions of the Public Utility Law.

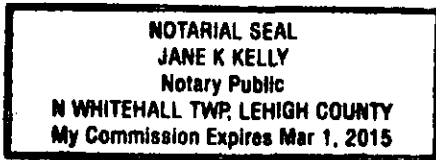

**A RESOLUTION APPROVING A RIGHT-OF-WAY AGREEMENT WITH PPL

AT 2684 LEVANS ROAD, NORTH WHITEHALL TOWNSHIP, LEHIGH
COUNTY, PENNSYLVANIA**

BE IT RESOLVED, at a duly convened meeting of the Township Supervisors of North Whitehall Township held May 14, 2012, as follows:

WHEREAS, PPL Electric Utilities has requested that the Township execute a Right-of-Way Agreement to provide service to the Ormrod Playground located at 2684 Levans Road, North Whitehall Township, Lehigh County.

WHEREAS, the aforementioned Agreement pertains to an area of land as depicted in the plan attached hereto as Exhibit A and described within the Agreement; and


WHEREAS, it appears to the Supervisors of North Whitehall Township that it would be in the interests of the public that the Agreement be executed to provide right-of-way to PPL Electric Utilities to allow service to the lands of the Ormrod Playground.

NOW THEREFORE, it is hereby resolved that the Township Supervisors of North Whitehall Township, pursuant to the authority vested in the Board of Supervisors of Second Class Townships governing the power to execute right-of-way agreements to provide utility services within the township, hereby agrees to execute the attached Right-of-Way Agreement granting said Right-of-Way to PPL Electric Utilities, in the Ormrod area of North Whitehall Township, Lehigh County, Pennsylvania, as described in Exhibit A attached hereto.

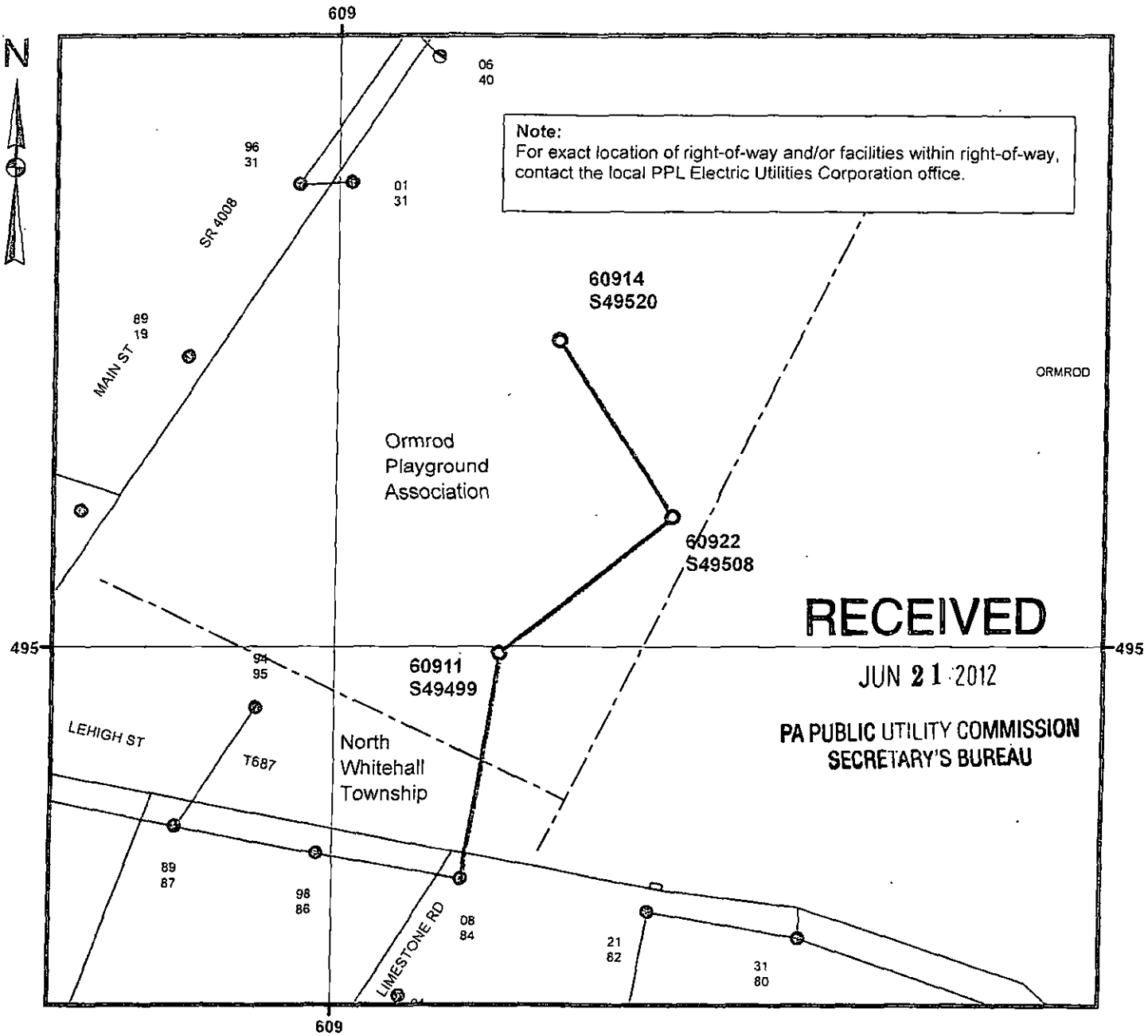

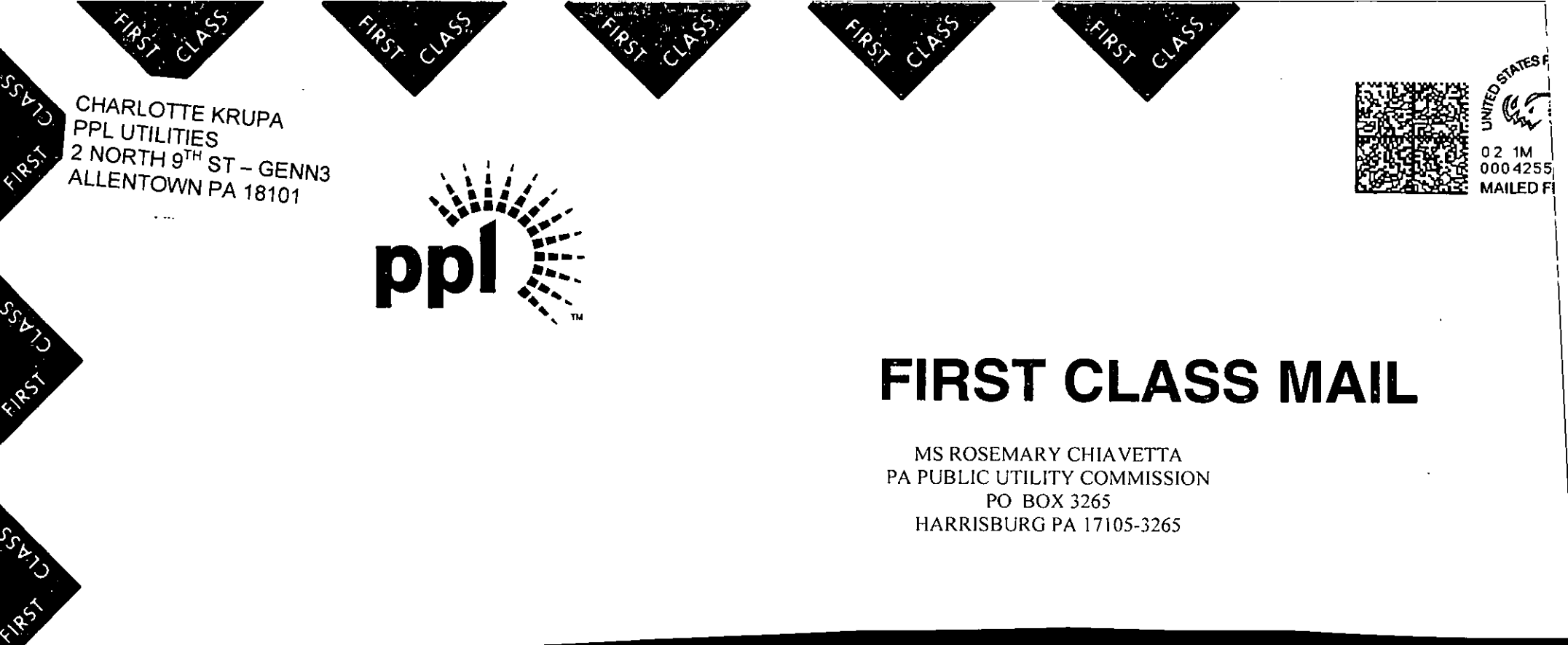

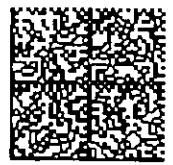
