

  - (a) Complainant, Faye Bigelow, and Respondent, PPL Electric, agree that Complaint will pay \$58 by July 1, 2012, which will be considered her June 2012 bill. Thereafter, beginning with the bill due July 2012, Complainant will pay her current monthly budget bill of \$63 plus \$65 per month towards arrearages, until all arrearages are paid in full.


(b) Complainant agrees to withdraw her Complaint.
