

1. Complainant is Angela Howard.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL Electric").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:
 - (a) Complainant, Angela Howard, and Respondent, PPL Electric, agree that Complaint will pay \$175 by the June bill due date (which is current charges of \$147 plus \$28 installment towards past due balance). Thereafter, beginning with the July 2012 bill, Complainant will pay her current monthly charges plus \$28 per month towards arrearages, until all arrearages are paid in full.

(b) Respondent, PPL Electric, has advised Complainant to enroll in budget billing in September 2012 for the winter billing. Complainant is eligible to reapply for the OnTrack after October 17, 2012.


(c) Complainant agrees to withdraw her Complaint.


