



CERTIFICATE OF SATISFACTION

1. Complainant is George Reynolds.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL Electric").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:

(a) Complainant, George Reynolds, and Respondent, PPL Electric, agree that beginning with the bill due July 2012, Complainant will pay his monthly bill plus \$100 per month towards arrearages. Thereafter, beginning with the bill due January 2013, Complainant will pay his current monthly bill plus \$700 per month towards arrearages, until all arrearages are paid in full. If Complainant fails to make any timely monthly payments, inclusive of the monthly bill plus the additional arrearage charge, the payment agreement will default and the

entire balance will become due. Moreover, if Complainant disconnects service, Complainant must continue to make monthly arrearage payments in the amount of \$100 from July 2012 through December 2012, and thereafter \$700 from January 2013 until all arrearages are paid in full.

(b) Complainant agrees to withdraw his Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests that the docket be marked closed in this matter.


