

 - (a) Complainant, Theresa Chestnut, has advised Respondent, PPL Electric, agree that PPL Electric will apply a credit to Complainant's account in the amount of \$199.16, which represents the late fees applied to the account. Moreover, it is agreed that beginning with the bill due July 2012, Complainant will pay her currently monthly bill plus \$54 per month towards arrearages, until all arrearages are paid in full.
 - (b) Complainant agrees to withdraw her Complaint.


