

CERTIFICATE OF SATISFACTION

1. Complainant is Walter Walls.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL Electric").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:

(a) Complainant, Walter Walls, and Respondent, PPL Electric, agree that Complainant will pay \$290 by July 5, 2012. Thereafter, Complainant will pay his monthly bill plus \$35 per month towards arrearages, until all arrearages are paid in full. Complainant has been referred to the OnTrack Program. Upon his completion of the application, he will submit same to PPL Electric. Additionally, Complaint closed his second account on May 14, 2012, and therefore this account will not be an issue for the OnTrack Program.


(b) Complainant agrees to withdraw his Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests that the docket be marked closed in this matter.
