CERTIFICATE OF SATISFACTION


1. Complainant is Crystal Huber.

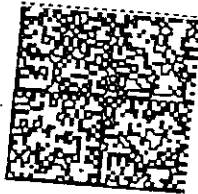
