



Application of Stream Energy Pennsylvania, LLC For Approval To Offer, Render, Furnish Natural Gas Supply Services as a Marketer/ Broker or Aggregator Engaged in The Business Of Supplying Natural Gas Supply Services, To The Public In The Commonwealth Of Pennsylvania, Docket No. A-2012-2308991.  
On June 11, 2012, Stream Energy Pennsylvania, LLC filed an application with the Pennsylvania Public Utility Commission ("PUC") for a license to provide natural gas supply services as (1) a supplier of natural gas, (2) a broker/ marketer engaged in the business of supplying natural gas, and (3) an aggregator engaged in the business of providing natural gas supply services. Stream Energy Pennsylvania LLC proposes to sell natural gas and related services in the service territory of PECO under the provisions of the new Natural Gas Choice and Competition Act.  
The PUC may consider this application without a hearing. Protests directed to the technical or financial fitness of Stream Energy Pennsylvania, LLC, may be filed within 15 days of the date of this notice with the Secretary of the PUC, P.O.
