1. Steve Atuahene has property interest in the

~~PA~~ scheduled for trial before Court of Common
Pleas of Philadelphia County under the
caption Frempong v. Redevelopment Authority
of the City of Philadelphia, CCP, February
Term 2011 No 1666.

2. Due to this case Steve Atuahene has
not been able to prepare for trial in
the instant case before the commission
scheduled for hearing on July 2, 2012

3. Therefore Steve Atuahene's request for continuance is not solely based on his relationship to condemnee Agnes Frempong but due to his own property interest in the condemned property as stated in the Affidavit being submitted with this supplement

4. Steve Atuahene a.k.a. Steve Frempong will be a witness in the Eminent Domain case to corroborate Agnes Frempong's testimony as to value of her property. See Columbia Gas Transmission Corporation v. Piper, 150 Commonwealth Ct 404, 615 A.2d 979 (1992).

Therefore the ~~case~~^{hearing} should be continued not only because of Steve Atuahene's relationship to Agnes Frempong but also because he is interested party who stands to lose his property right if he is not able to effectively participate in the Eminent Domain case pending before Court of Common Pleas of Philadelphia County.

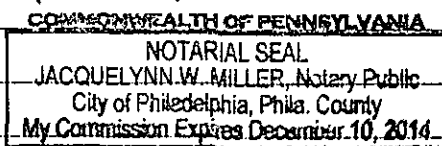
6. Steve Frempong, a.k.a Steve Atuahere was the developer of the property, developing it into multi-unit apartment complex

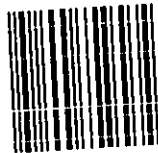
