I'm responding to PECO allegation  
about me being on there cap rate.  
I only remember being on cap  
1 time that I signed a form  
and they sent it to me, and  
I signed and returned it.

Your Honor, I'm going to be honest  
I messed up on that plan they  
given me, Now however I was  
told you had to be on cap for  
at least a year your Honor if  
I'm not mistaken, Could you have  
them you have them send you  
copies on whatever forms I  
suppose to signed for cap and  
I send you a copy of my license  
and you look at the signature  
your Honor, if its not to much  
to ask of you, Now if you look  
back throu the puc complaint

that i made before this matter  
came before you your "Honor".  
I was letting them know the  
process of going to do bankruptcy,  
So in December I get a bill  
saying 000 dollars. So i believe  
they started billing me, I never  
heard from peco until I was  
told to call, when I got my  
discharge papers and in form peco  
thats when I recieved a bill a  
day later stating I owe them  
4,000 dollars, I know my payment  
history doesnt look good at all with  
Peco. Your Honor thats why i went  
ahead and did bankruptcy so  
I can get back on track! your  
"Honor" but at the same time  
your "Honor" you have different  
agents you are speaking with  
telling you all different type  
of things about your bill, for  
instance after I called and let  
them know about my bill

They send me a shut off notice  
and said I had ten days to pay  
1,600 dollars. So I call them  
this is were I ask them if I  
can get a payment arrangement  
Your Honor I just did the  
bankruptcy. So I ask to speak  
with a supervisor she told me  
that bill was not real that's  
a fake bill they sent out. I  
said to her why would you  
do things like that to people.  
Your Honor I'm a person who's  
dealing mental illness Your Honor  
I did bankruptcy to start over  
Now your Honor pecc records there  
conversation. Your Honor I see  
that pecc says I had a 400  
dollars a month electric bill  
I called pecc and ask could  
they have someone come in  
my home to see why my bill  
is so high they said they were  
but know one was sent out.  
Now you Honor since I gotten

in touch with you and the  
puc my first bill was \$491 dollars  
\$281 and my bill for July \$163  
now it seems to go down.

I don't have a income rite  
now your "Honor" I have a child  
with a disability the income I  
get is 698 dollars for my son  
and child support 144 every 2 wks  
they had copies of my income  
when I was on there cap  
rate never seen a bill as low  
as 163, 281 my bill was 400  
dollars and that was there cap  
rate wasn't helping me your  
"Honor" I hope you can help  
me on this matter your "Honor"  
Someone really needs to do an  
investigation on puc openly and  
honestly. Your "Honor" "PUC" if you
