 - (a) Complainant, Constance Maddox, and Respondent, PPL Electric, agree that Complainant will pay \$171.23 by August 9, 2012. Thereafter, Complainant will pay her monthly budget bill plus \$15 per month towards arrearages, until all arrearages are paid in full. An Energy Saving booklet was sent to Complainant. In addition, Complainant was referred to Operation Help and LIHEAP.
 - (b) Complainant agrees to withdraw her Complaint.
