**PETITION OF THE
OFFICE OF SMALL BUSINESS ADVOCATE
FOR LEAVE TO WITHDRAW COMPLAINT**

Pursuant to Section 5.94(a) of the regulations of the Pennsylvania Public Utility Commission (“Commission”), 52 Pa. Code §5.94(a), the Office of Small Business Advocate (“OSBA”) hereby petitions for leave to withdraw its complaint against PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) at the above-captioned docket.

On May 18, 2012, PPL Electric filed the Calculation of Generation Supply Charge-1 for the period June 1, 2012, through August 31, 2012 (the “Application Period”) which was assigned to Docket No. M-2012-2305798 (“June 2012 GSC-1 Filing”).

The OSBA filed a Complaint against the rates, terms and other provisions contained in the June 2012 GSC-1 Filing on May 31, 2012, which was docketed at C-2012-2308443. This matter has not yet been assigned to an Administrative Law Judge.

At the time of filing the complaint commencing this matter, the OSBA had previously filed complaints against the Company's last four quarterly GSC-1 filings. The first complaint was against the Calculation of Generation Supply Charge-1 for the period June 1, 2011 through August 31, 2011 at Docket No. M-2011-2243137 ("June GSC-1 Filing"), which was docketed at C-2011-2245906. The second complaint was against the Calculation of Generation Supply Charge-1 for the period September 1, 2011 through November 30, 2011 at Docket No. M-2011-2258733 ("September GSC-1 Filing"), which was docketed at C-2011-2260010. The third complaint was against the Calculation of Generation Supply Charge-1 for the period December 1, 2011 through February 29, 2012 at Docket No. M-2011-224191 ("December GSC-1 Filing"), which was docketed at C-2011-2279176. The fourth complaint was against the Calculation of Generation Supply Charge-1 for the period March 1, 2012 through May 31, 2012 at Docket No. M-2012-2289949 ("March GSC-1 Filing"), which was docketed at C-2012-2291588.

Each of these complaints, as well as the instant complaint, raises issues about the reconciliation accounting method used by PPL Electric and the resultant reconciliation charges/credits to ratepayers through the GSC-1. The parties actively litigated the OSBA's complaint against the June GSC-1 Filing at C-2011-2245906. However, because all of the proceedings involve similar issues, the OSBA's subsequent complaints (at Docket Nos. C-2011-2260010, C-2011-2279176, and C-2012-2291588) were held in abeyance at the request of the parties to those proceedings pending the outcome of the OSBA's complaint against the June GSC-1 Filing.

The OSBA's first complaint at Docket No. C-2011-2245906 has now been fully litigated. The parties participated in an evidentiary hearing and submitted briefs. A

Recommended Decision was issued on April 2, 2012. PPL Electric submitted Exceptions and the OSBA submitted Reply Exceptions. The Commission issued an Opinion and Order on July 19, 2012. In that Order, the Commission largely rejected the ALJ's Recommended Decision and granted the Exceptions filed by PPL Electric. The Commission did, however, indicate that it intended to institute a generic proceeding dealing with the reconciliation issues raised by the OSBA in the litigated proceeding on a prospective statewide basis, Order at 26.

On July 26, 2012, the OSBA filed a Petition to Withdraw the complaint against the September GSC-1 Filing at Docket No. C-201160010. On July 30, 2012, the OSBA filed a Petition to Withdraw the complaint against the December GSC-1 Filing at Docket No. C-2011-2279176. The OSBA has also filed a Petition to Withdraw the complaint against the March GSC-1 Filing at Docket No. C-2012-2291588.

The OSBA submits that the specific reconciliation issues raised by the OSBA in the above-captioned complaint have been addressed by the Commission's Order at Docket No. C-2011-2245906 and will be more generally addressed in a statewide generic proceeding.

Further, counsel for PPL Electric has indicated that the Company has no objection to the withdrawal of the OSBA's complaint.

WHEREFORE, the Office of Small Business Advocate respectfully requests the Commission grant it leave to withdraw the Complaint at Docket Nos. M-2012-2305798 and C-2012-2308443 pursuant to 52 Pa. Code § 5.94(a).
