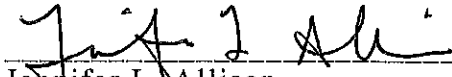
1. Respondent and Complainant discussed settlement of the case.

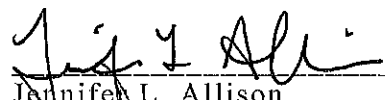
