Dear Ms. Muludiang:

Per your telephone conversation today with Regulatory Assessor, Charles Thomas, this letter confirms the settlement of the above-referenced Public Utility Commission (PUC) Complaint. As the parties desire to amicably resolve the dispute without the need for further litigation, PECO Energy has agreed to resolve your formal complaint as follows:

- (1) You will pay \$300.00 by August 30, 2012;
- (2) PECO Energy has cancelled \$36.19 in late payment charges;
- (3) PECO Energy has issued a payment agreement on a \$628.16 balance. Under the terms of the agreement, you are to pay \$104.69 per month for six (6) months plus the current utility charges.
- (4) For payments in excess of the \$104.69 monthly amount, call PECO Energy and request that excess payments be applied to the \$628.16 agreement balance.

This letter memorializes the entire agreement between Stacie Muludiang and PECO Energy Company. Any other terms or promises, written or oral, not body of this letter will not be a part of this settlement agreement and, therefore, will be void.

I will also forward a Certificate of Satisfaction to the PUC to inform them of our agreement. Unless you file a written objection to the PUC within ten (10) days, the Certificate of Satisfaction will sufficiently confirm to the PUC that the Complaint has been settled and the file will be closed.
