This letter is in regard to the complaint filed against me by the Bureau of Investigation & Enforcement docket no. C-2012-2314423. The complaint filed is due to failure to maintain evidence of Cargo insurance.

In June, 2012 I received a letter from PUC notifying myself that there would be a suspension of my operating authority due to evidence of Liability insurance coverage not being provided. I immediately contacted my insurance agency and notified them of this. On June 27, 2012 I received a letter from PUC stating that the suspension of my operating authority was lifted that evidence of Liability insurance coverage had been received. This is the only correspondence received from PUC until July 31, 2012 when I received a certified letter stating that a complaint has been filed against me from lack of evidence of Cargo insurance. This is the first correspondence I received regarding Cargo insurance. When I received this certified letter I immediately contacted my insurance agent to rectify this.

I have done all in my power to be diligent in providing the appropriate documentation to PUC to maintain my operating authority and to notify my insurance agent of the needed information to maintain my operating authority. I was not aware of the need for evidence of Cargo insurance until I received the notification of complaint filed. At that time I immediately contacted my insurance agent. I regret this oversight and am doing whatever necessary to correct this, however, until I received notification on both occasions from PUC regarding the lack of evidence of the appropriate insurance coverage I was not aware that National Casualty Insurance Company had not properly filed my credentials.
