

PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:
 - (a) Complainant, Richard Lynch, and Respondent, PPL Electric, agree that Complainant shall make payments on his account as follows: (1) Complainant shall pay his September 2012 bill by its due date, plus \$100 towards arrearages, (2) Complainant shall pay his October 2012 bill by its due date, plus \$600 towards his arrearages, and (3) beginning with the

bill due November 2012, Complainant shall pay his monthly bill plus \$150 towards arrearages, until all arrearages are paid in full.

(b) Complainant agrees to withdraw his Complaint.


