Dear Ms. Blanchette:

The Pennsylvania Public Utility Commission ("Commission") received your check dated July 25, 2012, check no. 6446, in the amount of \$368.00. Please be advised that this amount is insufficient because it does not cover the entire civil penalty that you owe, which is \$1,000.

On October 11, 2011, the Commission's Bureau of Investigation and Enforcement, filed a complaint against you because you failed to file assessment reports for four consecutive fiscal years – 2007, 2008, 2009 and 2010. Failing to file assessment reports constitutes a violation of section 510(b) of the Public Utility Code, 66 Pa. C.S. §510(b). The complaint requested that you pay a \$1,000 civil penalty.

Upon receiving the complaint, you had twenty days to file an answer disputing the allegations set forth therein. You did not file an answer.

On May 24, 2012, the Commission advised you by Secretarial Letter that the allegations in the complaint were deemed to be admitted and ordered you to pay \$1,000 within twenty days.

On July 26, 2012, the Commission received a copy of this Secretarial Letter from you, which contains hand-written notes that appear to report your 2011 calendar year revenues, as well as your computation of what you believe you should be assessed – or \$368.00. This is not an acceptable method of reporting your revenues for assessment purposes.

To date, you owe \$632.00 of the civil penalty. Please be advised that if payment is not made in full, you risk revocation of your certificate of public convenience.

In addition, enclosed is an assessment report so that you may properly report the revenues that you earned during the 2011 calendar year. I also enclosed instructions that

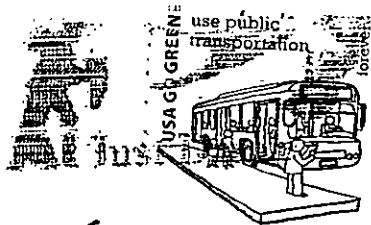
