

 - (a) Complainant, Angela Morganello, and Respondent, PPL Electric, agree that Complainant will pay \$170 by October 10, 2012. Thereafter, Complainant agrees to pay her monthly bill plus \$150 per month towards arrearages, until all arrearages are paid in full.
 - (b) Complainant withdraws her Complaint.
5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the


