Dear Mr. Puriefoy:

Per our conversation today before Special Agent David Alexander, this letter confirms the settlement of the above-referenced Public Utility Commission (PUC) Complaint. As the parties desire to amicably resolve the dispute without the need for further litigation, PECO Energy has agreed to resolve your formal complaint as follows:

- (1) You will pay \$165.85 by October 1, 2012;
- (2) PECO Energy will reinstate you to your prior payment agreement granted on April 10, 2012. Under this payment agreement, you are to pay \$29.95 per month plus your current budget bill for thirty-six months.

This letter memorializes the entire agreement between Charles Puriefoy and PECO Energy Company. Any other terms or promises, written or oral, not body of this letter will not be a part of this settlement agreement and, therefore, will be void.

I will also forward a Certificate of Satisfaction to the PUC to inform them of our agreement. Unless you file a written objection to the PUC within ten (10) days, the Certificate of Satisfaction will sufficiently confirm to the PUC that the Complaint has been settled and the file will be closed.
