
On May 31, 2012, your office served a Complaint against West Penn Power Company ("West Penn") filed by the Bureau of Investigation and Enforcement ("Complainant" or "I&E") which has been docketed at C-2012-2307244. On June 11, 2012, West Penn requested a forty-five (45) day extension which was granted on June 13, 2012, establishing August 6, 2012 as the due date for West Penn's filing of an Answer and/or other responsive pleadings. Subsequently, by letter dated July 23, 2012, a further extension of time was granted by your Office, setting August 27, 2012 as the due date for the filing of West Penn's Answer and/or other responsive pleadings. By letter dated August 24, 2012, West Penn requested a further extension of time to Monday, October 1, 2012 as the due date in this matter for the filing of West Penn's Answer and/or other responsive pleadings. 
